COVID-19 Case Summary for Colchester

Since the start of the school year, the Colchester School District has had a total of 24 individuals who tested positive for COVID-19 and were determined by the Health Department to have been in school while they were infectious.

From the above cases, 12 resulted in individual close contacts being quarantined and the other 12 cases resulted in individual close contacts being quarantined as well as a classroom or program being moved to full remote learning until the end of the quarantine period.

Out of the 24 cases, one case at UMS was deemed to have in-school transmission. We attribute the low rate of in-school transmission to our commitment to the mitigation strategies that we have put in place across the district. Masks, handwashing, physical distancing, remote meetings, and staying home when sick are all important strategies for us to use to keep our schools safe and open for learning.

Vaccination Information

During Governor Scott's press conference on Tuesday, we learned that the next phase of vaccinations will include school employees, childcare employees and additional public safety employees. In Vermont, more than 80% of Vermont educators expressed that they are interested in being vaccinated through a survey distributed by the Vermont Agency of Education. We are still waiting for guidance regarding any potential vaccination requirements or exemptions that might be in place this fall for school employees and students.

How the Vaccine May Impact School

The vaccine's effectiveness at preventing infection is key to Vermont beginning to return to normal. However, Vermont's Safety and Health Guidance for Schools, which requires students to be physically distanced 3 feet at the elementary level and 6 feet at the middle/high school level, has not changed. We are in regular communication with the Vermont Agency of Education and will continue to monitor any changes closely. As the weather warms and we get closer to spring, we are hopeful that COVID cases will decline which may lead to us seeing a change in the State's guidance. As always, we will keep our entire school community informed every step of the way.
