Emergency Notification Test

The district will be conducting an annual routine test of our emergency notification system on <u>Wednesday, November 10 at 6:00 pm</u>. The test notification will go out to all families using the contact information on file with the district. Changes to COVID Testing Options at CSD

As we've shared in several recent emails, the district has been evaluating and assessing the various testing options offered by the state to determine how we can implement them locally. Tomorrow, we will be sending a stand-alone email with detailed information about the testing options we will offer moving forward and how to sign up.

Winter Sports and Co-curriculars

Sixteen school districts covering Addison, Chittenden, Franklin, and Grand Isle Counties who are members of the Champlain Valley Superintendents Association (CVSA), have developed common agreements across the region for sports and co-curricular events during the winter season based on the Winter Sports Advisory Memo from the Agency of Education.

If an athlete is vaccinated, they will not be required to quarantine should an exposure occur. Participation in the upcoming Test to Stay program will allow unvaccinated athletes to continue to participate in team-based practices during their quarantine, however, it <u>will not enable</u> involvement in interscholastic competition (i.e., games, meets or competitions).

Depending on the school facility, locker rooms may be used by both visiting and home teams this winter season. **Masks are required by ALL student-athletes**, coaching staff, referees, and spectators during indoor practices, competitions, and games, regardless of individual vaccination status. Exceptions to this are limited. Athletes participating in wrestling, gymnastics, indoor track, cheer, and dance skills are exempt when participating in the physical skills of that activity. When these athletes are not actively competing, masks will be worn.

Spectators/audience members will be allowed for all athletic and co-curricular activities (music, drama, etc). **Masks are required for all spectators and audience members** and must remain on at all times unless eating in the designated eating area. Please leave space between your family and others. We will monitor gym capacity and may limit ticket sales for larger events. At this time, we are setting the capacity of the CHS Performing Arts Center to 200 tickets per event and we will continue to assess capacity based on health conditions. Contact tracing for spectators will be done by the Vermont Health Department, and we strongly encourage that you take note of the section of the gym you are in and/or

your seat number in the CHS Performing Arts Center. If protocols are not followed, future events may need to have a limitation on spectators or no spectators at all.

Community members attending competitive events can also expect to hear a statement read aloud reminding participants and spectators that Vermont law requires learning environments free from hazing, harassment and bullying of any kind. This is especially true with respect to a person's race, gender, sexual orientation, religion, national origin, ethnic differences, or disability. Under no circumstances should any students, judges, officials, or coaches be subjected to behavior and/or language aimed to demean, disrespect or harm.

Our spectators can expect that if behavior or hate speech of this kind is observed and/or reported at a competitive event that the officials will stop the event immediately to meet with the coaches and the site administrator about the next course of action. Possible outcomes of violating this expectation range from immediate ejection from the event, ending the event early, forfeiture, rescheduling the event or future events without fans. Sportsmanship and a safe environment are a top priority for all Vermont school-sponsored activities. Thank you to our entire community for helping ensure the highest levels of respect and safety for all.
