Board of Education Meeting Colchester High School Library Tuesday, August 16, 2011 7:00 p.m. (General Session)

The Colchester Board of Education held a regular board meeting on Tuesday, August 16, 2011 at the Colchester High School Library. # MINUTES (General Session)

### I. Call to Order

Vice Chair Dick Pecor called the meeting to order at 7:00 p.m.

### II. Pledge of Allegiance

Vice Chair Dick Pecor led in the Pledge of Allegiance.

## III. Approval of Minutes: June 21, July 19 & August 5, 2011

Director Paul Smith moved to approve the minutes of July 21, July 19 and August 5, 2011, seconded by Director Steve Cormier. Motion passed unanimously.

### V. School Board Communication, Committee Reports & Correspondence

- Board members want to invite local representatives to a meeting to discuss the Governor's position on School Choice.
- Principals reported on school preparation plans for the start of the 2011-2012 school year.
- Superintendent Waters recommended the Board approve a school choice agreement between Franklin Northwest Supervisory Union (Missisquoi Valley Union High School) and our district (Colchester High School) for one year only. Director Paul Smith moved to accept an agreement of intent to allow a CHS student to attend MVUHS under an acceptable school choice agreement for one year only, seconded by Director Steve Cormier. Motion passed unanimously.
- Superintendent Larry Waters continues to support the Colchester Middle School Leadership Team.
- Employee service awards will be presented to CSD staff on August 26 at 11:30 a.m. in the CHS theater.
- Director Paul Smith reported that the Colchester Community Band, led by CHS Music Teacher Evan Peltier, has played at several local events recently.

# VI. Colchester Middle School: Approval for an Additional Administrator (1-year only) and Update on CMS Educational Leadership Team

Superintendent Larry Waters discussed the need for additional administrative support at Colchester Middle School for the 2011-2012 school year. Director Paul Smith moved to support the Superintendent's recommendation to approve a ten month Assistant Principal position at Colchester Middle School for one year only, seconded by Director Steve Cormier. Motion passed unanimously.

# VII. Malletts Bay School Pilot Program Approval: UVM Health Project to Learn About the Effects of Before-School Physical Activities on Children's Academic Performance, Mood and Health

Principal Julie Benay presented an overview of the proposed pilot program between Malletts Bay School and the University of Vermont. It was noted that UVM students supervising the MBS program in the morning will be subject to a criminal records check. Concerns were expressed regarding the program's early start time (7:30 a.m.), bus transportation in the morning (MBS students cannot ride on CMS buses), and the control vs. test group choice. Director Steve Cormier moved to approve the Wellness Research Project with the University of Vermont, seconded by Director Paul Smith. Motion passed unanimously.

## VIII. Approval for Colchester Middle School Roof Repairs

Business and Operations Manager George Trieb reported that a section of the CMS roof needs to be replaced. Based on the bids he received from three roofing companies, Mr. Trieb recommends the Board accept the bid from Evergreen Roofing. Director Steve Cormier moved to accept the bid from Evergreen Roofing and authorize the Business and Operations Manager to execute the necessary documents to make this happen, seconded by Director Paul Smith. Motion passed unanimously.

### IX. Approval for Business Deposit Account Certified Resolutions

People's United Bank requires a signature on a financial document. Business and Operations Manager George Trieb explained the need for the document and requested Board authorization. Director Steve Cormier moved to approve the Board Chair, or designee, to sign as signatory for the Account Certified Resolution.
