Board of Education Special Meeting Central Office Conference Room Tuesday, March 12, 2013 7:00 p.m. (General Session)

The Colchester Board of Education held a special board meeting on Tuesday, March 12, 2013, in the Central Office Conference Room. Those in attendance were: Directors: Craig Kieny, Dick Pecor, Mike Rogers, Christine Shepard, and Lincoln White; and Superintendent, Larry Waters.
