The Colchester Board of Education held an executive session board meeting on Tuesday, May 7, 2013, in the Colchester High School Tech Room. Board of Education Meeting Colchester High School Media Center Tuesday, May 7, 2013 7:00 p.m. (General Session)

The Colchester Board of Education held a regular board meeting on Tuesday, May 7, 2013, in the Colchester High School Media Center. Those in attendance were: Board Chair: Dick Pecor, Directors: Craig Kieny, Mike Rogers, Christine Shepard, and Lincoln White. Student Board Member: Jordan Isham. Superintendent, Larry Waters; Business & Operations Manager, George Trieb; Director of Curriculum & Instruction, Gwen Carmolli; and Director of Special Education, Carrie Lutz. Principals: Chris Antonicci, Julie Benay, Dawn Gruss, Jim Marshall, and Amy Minor. There were 8 members of the community in attendance.

I. Call to Order

Board Chair Dick Pecor called the meeting to order at 7:00 p.m.

II. Pledge of Allegiance

Board Chair Dick Pecor led in the Pledge of Allegiance.

III. Citizen Participation

There was no citizen participation.

IV. Approval of Minutes: April 30, 2013

Director Christine Shepard moved to approve the minutes of April 30, 2013, with suggested amendment to Section III, seconded by Director Craig Kieny. Motion passed unanimously.

V. School Board Communication, Committee Reports & Correspondence

Superintendent Larry Waters provided some legislative updates including Universal Prekindergarten Access (H.270), Education Funding (H.538), Flexible pathways (S.130), Agency Fees (S.14), and Education Property Tax Rates (H.265).

Superintendent Waters encouraged the board to read the letter Principal Dawn Gruss received from the Vermont Reads Institute (VRI) at the University of Vermont. Colchester Middle School has been successful in closing the gap in reading and writing.

Business & Operations Manager George Trieb reviewed the quarterly Financial Report for FY'13. Revenues and expenditures are tracking mostly as expected. Professional Education Services (0320) and Tuition to Private Schools (0566) is tracking over budget.

Director of Special Education Carrie Lutz provided a quarterly update for Special Education. Currently, 300 students qualify for special education services. Director Lutz stated that expenses are being monitored, in-house support is being used to cover needs, and they will be participating in a UVM study around absenteeism.

VI. Malletts Bay School Report

Principal Julie Benay provided the school board and community with a detailed presentation about Malletts Bay School. The presentation included a range of information from enrollment, class size, demographics, attendance, student discipline, reading/writing/math instruction, NECAP results, heath, student leadership, and parent and community support.

During Principal Benay's presentation, Principal Jim Marshall announced the results of the budget vote - the budget passed 1,041 to 918.

VII. Principal's Report on Athletic Funding Structure at Colchester High School

Principal Amy Minor and Assistant Principal Tim Emery provided the school board and community with a detailed presentation on the Athletic Funding Structure at Colchester High School (CHS).

It is important to understand that funding to support athletics at CHS is only partially provided by the voter budget. A significant amount of supplemental funding comes through fundraising sponsored by booster clubs and donations.

VIII. Approval of School Safety Improvement at Union Memorial School, Porters Point School, Malletts Bay School, and Colchester Middle School

Superintendent Larry Waters reviewed the recommended School Safety Report for Union Memorial School, Porters Point School, Malletts Bay School, and Colchester Middle School. The report stated replacing locks, doors, and providing keyless entry badges. Colchester High School was not included in this report (improvements will be provided at a later date) as the high school has several more entries to secure and it will take time to determine the most effective way to secure the building.

Director Christine Shepard moved, seconded by Director Craig Kieny, to approve the Superintendent's recommendation to install safety doors and monitoring systems at each of the schools (PPS, UMS, MBS, CMS) and to authorize the business manager to complete the project for the start of the next school year. Motion passed unanimously.

IX. Preparing for Negotiations Fall 2013

The next round of negotiations with the CEA will begin this Fall 2013.

Superintendent Larry Waters reviewed a Guide to Collective Bargaining. The guide included:

Christine Shepard, Lincoln White, and Craig Kieny have agreed to participate in the negotiations.
