## VI. Approval of Colchester School District Announced Tuition Rates FY'15

## VII. Hear New Technology Recommendations for 2014-2015

The technology committee recommends purchasing laptops and chrome books for students in grades 7, 8, and 9 (approximately \$150,000 including Professional Development) without the assistance of an integration teacher. This approach saves the district approximately \$50,000 from the original recommendation of providing a technology integration specialist for grades 6 - 12.

Superintendent Larry Waters reviewed the baseline budget – FY '15 with recommended reductions. The board requested three-year actual budget amounts and additional review of budget options.
