MINUTES (General Session)

The Colchester Board of Education held a regular board meeting on Tuesday, December 16, 2014, in the Colchester High School Media Center. V. Hear Prekindergarten Program – Act 166 Presentation Overview

Director of Special Education Carrie Lutz and Early Interventionist Teacher Nancy Smith presented an overview of Act 166 – Universal Prekindergarten.

Act 166 entitles three, four, and five-year-old children (who are not attending kindergarten) to 10 hours per week of publicly funded prekindergarten education for 35 weeks in qualified centers.

Director Craig Kieny moved, seconded by Director Lindsey Cox, to approve the contract agreement with the ACA for the years 2015-2016, 2016-2017, and 2017-2018 as outlined. Motion passed unanimously, 3-0.
