The Colchester Board of Education held an open session on Tuesday, September, 1, 2015, from 6:00 p.m. to 7:00 p.m. in CHS Room 114A. I. Call to Order and Pledge of Allegiance

Chair Mike Rogers called the meeting to order at 7:10 p.m. Chair Mike Rogers led in the Pledge of Allegiance.

III. Approval of Changes to Teacher Evaluation Model

Superintendent Larry Waters reviewed changes made to the Colchester School District Teacher Evaluation Model. Over the years, the VT Agency of Education changed the teacher relicensing process and requirements. Superintendent Waters recommended changing the current teacher evaluation model that was designed on a 7-year plan to a new 3-year plan (one year direct supervision and two years of professional development).

Director Lindsey Cox moved, seconded by Director Curt Taylor, to approve the recommended changes to the CSD Teacher Evaluation Model. Motion passed unanimously, 5-0.

IV. Hear Possible Changes to the Personnel Leave Policy

Superintendent Larry Waters shared the current Personnel Leave Policy with the school board and community. Discussion focused on the purpose of the policy and what, if any, changes should be made.

V. Hear Smarter Balance Assessment Results for Colchester School District

Director of Curriculum & Instruction Gwen Carmolli provided an overview of the assessment results to the board and community. Smarter Balance Assessments were given to students in grades 3 through 8 and grade 11 in the Spring 2015. Colchester students scored above state averages in every grade in literacy and math.

VI. Year-End Financial Report for 2015

Business & Operations Manager George Trieb reviewed revenue and expense figures for the year ending June 2015. The district finished the year with a \$1,203,571 surplus.

VII. Hear Report on CMS/CHS Co-Curricular Salary Groups

Superintendent Waters reported moving programs from Group V to Group IV on the CMS/CHS co-curricular salary groups would result in an additional \$18,000 in personnel cost to the current programs offered.
