POLICY: CONTINUOUS IMPROVEMENT PLAN

DATE ADOPTED: DRAFT

POLICY STATEMENT

In accordance with state law, it is the policy of the Colchester School District to establish annually a Continuous Improvement Plan (CIP) for the district as a whole, as well as individual CIPs for each school located in the district. These plans must be based on student achievement data and shall set forth goals and associated resources needed to improve student performance.

POLICY: CAREGIVER AND COMMUNITY INVOLVEMENT POLICY

DATE ADOPTED: DRAFT

PURPOSE

It is the policy of the Colchester School District to encourage and support the involvement of caregivers in their child's education. Research has shown that caregiver involvement is a key factor in the academic and social success of students. The board believes it is important that caregivers are involved in their child's education at home, in school and within the larger community. New educational initiatives mandate or encourage the strengthening of relationships between the caregiver, community and school.

I. <u>DEFINITION</u>

<u>Caregiver:</u> Includes a parent, legal guardian or other person who is legally responsible for the child's welfare.

II. <u>IMPLEMENTATION</u>

To facilitate involvement, the superintendent or their designee shall develop programs and procedures to accomplish the following objectives.

- **A.** Caregivers should be informed about their children's educational programs and instructional methods and objectives. They should be notified directly of any significant changes.
- **B.** Caregivers and the community should be provided with opportunities to become informed and communicate with educators on subjects such as program design, operations and evaluation.
- C. Caregivers should be encouraged to observe instructional activities, attend program meetings, discuss concerns with educators, participate in improvement efforts and to give recommendations to school staff, administration and board members.
- **D.** Caregivers should be provided with information and opportunities intended to improve their abilities to work with their children at home and in school and to build partnerships between homes and schools.

- **E.** Faculty staff, administrators, school board members and school-community partners should be offered training opportunities intended to improve their abilities to build and maintain effective relationships with caregivers.
- **F.** Community members, caregivers, and families should have access to continuous improvement plans, school reports, and other relevant data as part of the Vermont Education Quality Standards.

III. TITLE I

The district maintains programs, activities and procedures for the involvement of caregivers of students receiving services or enrolled in programs under Title I, Part A.

POLICY: TITLE I COMPARABILITY

DATE ADOPTED: DRAFT

POLICY STATEMENT

The Colchester School District shall use local and state funds to ensure equivalence among schools. All students, regardless of which school they attend, shall have access to comparable programs and supplemental supports. If a school in the district becomes eligible to receive Title I funds, the district shall provide comparable services, staffing levels, curriculum materials and instructional supplies to both the Title I eligible school and non-Title I eligible schools.

The superintendent, or their designee, shall develop procedures for compliance with this policy to include utilizing the district-wide salary schedules, implementing a centrally controlled curriculum plan, ensuring parental/caregiver involvement compacts and maintaining and updating records that demonstrate compliance.

CAREGIVER INVOLVEMENT

For the purpose of this policy, caregiver is defined as a parent, legal guardian or other person who is legally responsible for the child's welfare. The district maintains programs, activities and procedures for the involvement of caregivers of students receiving services or enrolled in programs under Title 1, Part A. These programs, activities and procedures are described in district and school level compacts.

I. District Level Caregiver Involvement Compact

The superintendent, or their designee, shall develop a District Level Caregiver Involvement Compact according to Title I, Part A requirements. The compact shall include: the school district's expectations for caregiver involvement, specific strategies for effective caregiver involvement activities to improve student academic achievement and school performance, and other provisions required by law. The superintendent or designee shall ensure that the compact is distributed to caregivers of students receiving services, or enrolled in programs, under Title I, Part A.

II. School Level Caregiver Involvement Compact

Each building principal, or their designee, shall develop a School Level Caregiver Involvement Compact in accord with Title I, Part A requirements. The compact

shall include: a process for continually involving caregivers in its development and implementation, how caregivers, the entire school staff and students share the responsibility for improved academic achievement, the means by which the school and caregivers build and develop a partnership to help students achieve the State's standards, and other provisions as required by law. Each principal or designee shall ensure that the compact is distributed to caregivers of students receiving services, or enrolled in programs under Title I, Part A.

MINUTES (General Session)

The Colchester Board of Education held a regular board meeting on Tuesday, September 17, 2019, at the Colchester High School Media Center. Those in attendance were Board Chair Mike Rogers; Directors: Craig Kieny, Lindsey Cox and Lincoln White; Director Curt Taylor attended via phone; Student Representative Mitch Gadapee; Superintendent Amy Minor; Director of Curriculum Gwendolyn Carmolli, Director of Student Support Services Carrie Lutz; Principals: Carolyn Millham and Chris Antonicci.

I. Call to Order and Pledge of Allegiance

Board Chair Mike Rogers called the meeting to order at 7:02 p.m. and led in the Pledge of Allegiance.

II. Citizen Participation

None.

III. Report from Building Principals

Information

Both principals in attendance shared that school has been operating smoothly since they welcomed everyone back. Principal Millham is looking forward to their open house on Thursday and invited the board to attend.

IV. Approval of CHS Music Department Trip to New York City

Action

This item was held for the next meeting.

V. Annual School Report: Union Memorial School

Information

This year, the schools are debuting a new format for their annual reports. Their presentations to the board will focus on goals outlined in their Continuous Improvement Plans (CIP) and they will supply an accompanying fact sheet which will include information such as enrollment, demographics, behavior and academic testing data from the 2018-2019 school year.

Union Memorial School Principal, Chris Antonicci, was the first to present his school report to the board. He started by providing an overview of the school's CIP goals. Academically, those goals were focused on developing and implementing a new science curriculum and evolving the way they provide reading instruction to improve student comprehension and test scores. From a behavioral perspective, their CIP goal was to continue to offer targeted positive interventions to students needing additional support.

The board engaged Principal Antonicci on sections of the academic data asking more specific questions about which cohorts of students were tested, what the testing looked like and how often it was administered.

VI. Second and Final Reading of Fiscal and Business Management Policy: E1 Action

No edits requested.

Director Kieny moved to approve the second and final reading of the Fiscal and Business Management Policy: E1, seconded by Director Cox. The motion passed unanimously, 5-0.

VII. First Reading of Location Action Plan Policy: G8

Action

This policy was brought before the board as part of the policy revision cycle. It was last reviewed in 2003. The only recommended change was to update "Local Action Plan" to "Continuous Improvement Plan" to reflect the current language used by the VT Agency of Education.

Director Cox moved to approve the first reading of the Continuous Improvement Plan Policy: G8, seconded by Director White. The motion passed unanimously, 5-0.

VIII. First Reading of Parents and Community Involvement Policy: H2

Action

This policy was brought before the board as part of the policy revision cycle. It was last reviewed in 2007. To reflect the evolving dynamic of families in the district, the word "parent" was replaced with "caregiver". The majority of the content was kept the same, however, the old mission statement was removed and some research-based language suggested by the Vermont School Board Association was added. Also added was a section specifically referencing the involvement of caregivers of students receiving Title 1 services. Director Cox voiced concerned with the term "caregiver" as a replacement for "parent". Although she agrees with the need to expand the exclusiveness of the term "parent", she asked if "caregiver" could be defined as a legal guardian in the policy to make it more explicit in regards to the release of information under federal education privacy laws. Director White asked that there be added language speaking to the involvement of the community. Director Taylor requested several wording changes in the implementation section.

Director Cox moved to approve the first reading of the Caregivers and Community Involvement Policy: H2, seconded by Director Kieny. The motion passed unanimously, 5-0.

IX. First Reading of Comparability Policy: G2

Action

This policy was brought before the board as part of the policy revision cycle. It was last reviewed in 2005. This policy is required in order for the district to receive Title funds. For that reason, it was suggested that the title of the policy include the term "Title I". The draft policy is reformatted and has some updated content and language to better align with the Vermont School Board Association's model policy.

Director Kieny moved to approve the first reading of the Title I Comparability Policy: G2, seconded by Director White. The motion passed unanimously, 5-0.
